

THE ROOT CANAL JOURNEY - FROM DIAGNOSIS TO OBTURATION HANDS-ON WORKSHOP

COURSE DESCRIPTION

Do you want to improve the endodontic care you provide for your patients? This half-day hands-on course is designed for general dentists to help them improve the quality of their root canal treatments. Participants will learn advanced NiTi rotary-reciprocation instrumentation, predictable irrigation protocols using ultrasound and Apical Negative Pressure irrigation. Warm vertical obturation using the Continuous Wave condensation technique and the hydraulic technique. Other topics will include location of calcified canals, creation of a glide path, determination of working length, and location of the MB2. This program highlights solutions and suggestions on how to treat straightforward and some complex endodontic cases. This hands-on workshop utilizes 3D printed teeth and is designed to enhance the clinicians' practical skills.

- Assess protocols for location and negotiation of some complicated cases.

- Utilize and learn agitation and activation irrigation methods and technology to improve dissolution of organic tissue and removal of biofilm from the root canal system.
- Demonstrate obturation of the root canal system in 3D to capture the natural anatomy with the continuous wave of condensation and hydraulic techniques.
